US LEGISLATION UPDATES FLAME RETARDANTS IN CHILDREN'S PRODUCTS AND FURNITURE

A number of States in the US have introduced bills to restrict certain flame retardants in consumer products. These bills essentially prohibit the use of flame retardants from the TRIS family in children's products and upholstered furniture.

In 1977, the US Consumer Product Safety Commission (CPSC) announced the prohibition of the flame retardant tris-(2,3-dibromopropyl) phosphate (TDBPP, also known as TRIS) in children's wearing apparel.¹

In August 2011, New York State approved a measure to prohibit the flame retardant tris-(2-chloroethy) phosphate (TCEP, also referred to as TRIS) in toys and childcare articles for children under the age of 3. The law will be enforced on 1 December 2013.²

In October 2011, California incorporated the flame retardant Tris-(1,3-dichloro-2-propyl) phosphate, TDCPP (yet again known as TRIS), into the Proposition 65 (Prop 65) list of chemicals as a chemical known to the State to cause cancer. Once the chemical was listed, businesses had 12 months to comply with Prop 65 warning requirements.

In January 2013, we informed you that the Center for Environmental Health (CEH), a non-profit organisation, initiated the first ever legal action against retailers for products containing TDCPP in violation of Prop 65³. The flame retardant TDCPP is used in a range of applications including polyurethane (PU) foam materials, plastics, resins and fabric backings.

Since the beginning of 2013, a number of states in the US have introduced bills (proposals) to restrict flame retardants, including TDCPP and other members of the 'TRIS' family, in children's products and upholstered furniture. Highlights of these are summarised in Table 1.
