EU COSMETIC REGULATION 1223/2009

Cosmetic Products Regulation EC 1223 / 2009 will take full effect from 11 July 2013. It will supersede Directive 76 / 768 / EEC. The regulation is a natural evolution from the 1976 directive and reflects more than 30 years of new technology and innovation used by the cosmetic industry. Unlike its 1976 predecessor, the new regulation is a legislative act that imposes clear and detailed rules, and is immediately enforceable in all member states.

The Annexes of the Directive 76/ 768/ EEC were aimed to address potential risks to human health. With advances in technical and scientific progress these Annexes have been amended and Regulation EU No 344/ 2013 makes these changes for the new Regulation 1223/ 2009.

Under the new Cosmetic Regulation EU Manufacturers, importers and retailers of cosmetics are designated "Responsible Persons" with the legal liability to ensure that their cosmetic brands comply with the new Regulation. Notification is a prerequisite for any cosmetic product on the market as of July 2013 and documents for the Product Information File (PIF) can be requested for review by the EU Authorities at any time.

The PIF must include the following data:

- Product description
- Product name
- Unique Internal formulation reference
- Language variations
- Product function
- Finished product specification
- Primary and secondary artwork
- Cosmetic Product Safety Report
- Method of manufacture / GMP statement
- Proof of effect
- Historic animal testing data
- Ingredient Material Safety Data Sheets (MSDS)



The PIF must be kept for 10 years after the last batch of the product is placed on the market.

All cosmetic products on the market on July 2013 shall meet these requirements.
