## CPSIA PART 7: US STATE OF WASHINGTON FOLLOWS CPSIA

The state of Washington withdrew rule making to implement Children's Safe Products Act (CPSA). The CPSIA preempts Washington's standards for lead, cadmium and phthalates but some important parts of Washington's law will remain in effect.

In April 2008, the Governor of the state of Washington signed HB 2647 (Dickinson, 2008) into law to set the strict standards for lead, cadmium and phthalates for children's products<sup>1</sup>. The legislation would be effective on July 1st, 2009.

On November 12th, 2008, the Department of Ecology decided to withdraw its rule making process for the implementation of CPSA<sup>2</sup>. The decision was based on its assessment that the federal legislation CPSIA substantially preempts CPSA and its standards for lead, cadmium and phthalates (Laws of 2008, Chapter 288). This federal preemption precludes the need for the proposed rule because the purpose was to clarify how the lead, cadmium and phthalate standards apply to certain products.

There are however parts of Washington's law (Laws of 2008, Chapter 288) that are not preempted as highlighted below:

- Develop a list of Chemicals of High Concern for Children (CHCC)
- In January 2009, Department of Ecology with assistance from Health will present a report to Washington State legislature:
  - ⇒ Describing the processes how CHCCs are identified,
  - ⇒ Addressing concerns raised, particularly by small manufacturers and retailers, about the reporting requirements,
  - ⇒ Describing how the new law affects the availability of safe car seats in Washington; and
  - ⇒ Identifying children's products or product categories that contain CHCCs.



By the summer of 2009, Ecology expects to begin rule making for children's products containing CHCCs. This rule will also contain reporting requirements and such requirements will be expected to become effective in spring 2011 at the earliest.
