KOREA CERTIFICATION (KC MARK): IMPACT ON KOREA TEXTILE COMMODITIES

Ministry of Knowledge Economy (MKE) of Korea has implemented a New National Unified Mark, called KC Mark (stands for "Korea Certification"). This is a legally compulsory certification mark that must appear on products as specified in related laws and ordinances.

Overview of KC Mark System:

- To protect public health and safety, companies are required to obtain approval of a certification mark from an authorized body before certain products will be allowed to be sold in the marketplace. Items subject to legally compulsory certification are specified in related laws and ordinances pertaining to safety, health, environment and quality.
- Currently, diverse certification marks cause confusion among consumers, and have also proven costly and time consuming for businesses.
- To resolve this problem, the Korean Agency for Technology and Standards (KATS) revised the Framework Act on National Standards and its Enforcement Decree and introduced the unified Korea Certification Mark on July 1, 2009.
- This one single Korea Certification mark ("KC mark"), integrates and unifies all 13 existing legally compulsory certification marks.

BENEFITS FOR CONSUMERS & COMPANIES

Consumers can rely on the KC Mark when choosing safe, healthy, environmentally friendly and quality products. Companies will save time and cost thanks to the streamlined certification processes, which eliminates redundant procedures.

IMPACT OF "KC MARK" FOR THE KOREAN TEXTILE AND GARMENT INDUSTRY

In Korea, textile products are regulated by the **Self Regulatory Safety Confirmation Act**¹ and the **Safety Quality Mark Act**². Every product (including imported goods) sold in the Korean market is required to comply with these two acts. This is a mandatory requirement for all textile/apparel items sold or imported into Korea.

The KC mark became effective on January 1, 2010. This is a compulsory legally certification mark that must appear on products specified in related laws and ordinances. The **KC Mark for the Self Regulatory Safety Confirmation Act**, must be authorized by the Korean Government. The **KC Mark for the Safety Quality Mark Act**, is a self declaration of conformity from manufacturers or importers.

SCOPE OF SELF REGULATORY SAFETY CONFIRMATION ACT AND SAFETY QUALITY MARK ACT

1. Self Regulatory Safety Confirmation Act

The manufacturers or the importers of products covered by the Act must have the products tested by an authorized testing and inspection institution. The products must meet the corresponding standards to qualify for the KC Mark and to import or sell their products in Korea.

Remark:

- ¹ Only for coated/printed textile products

Restricted substances complied with KSK 0147, KSK 0734.
- ³ Only for products using coating materials, rubber or plastic. Test List: DNOP, DEHP, BBP, DBP, DINP & DIDP.
- ⁴ Only for flame retardant products. Test list: TDBPP, PentaBDE & OctaBDE.
- ⁵ Only for parts using leather materials.
- ⁶ Only for clothing with coating, printing & button (In case of metal, the requirement is 300 (mg/kg).
- ⁷ Only for products with a cord or drawstring.

2. Safety Quality Mark Act

In order to sell or import products for sale in Korea and to receive the KC Mark for the Safety Quality Mark Act, the manufacturers or the importers of products covered by the Act must indicate that the products meet the corresponding safety requirements.

Certification obtained under the previous system will remain valid. The KC Mark can be used simultaneously with existing marks until June 30, 2011. As of July 1, 2009, the KC Mark will be required to be attached to all new products subject to compulsory certification.
